Note from the Principal's Office...

Dear Parents and/or Guardians,

We are excited to kick off the second semester, while also starting to plan for what is coming this fall. We had the opportunity to meet with many of our students to evaluate what has been going well and help identify areas of improvement. While much of the feedback will be aligned with changes for next year, we are also looking at some changes this semester to better support our students this semester. We have established some great routines and flow in our new space, and as we enter this semester, we look forward to better utilizing some of our intentionally designed spaces.

As we closed out the first semester, we had some incredible presentations of learning and collaboration. Frequently Asked Questions about water testing in Poudre School District schools

Upon being informed that a Wellington Middle-High School (WMHS) chemistry class found elevated levels of copper in water from two drinking fountains at the school on Dec. 19, PSD staff collected samples from multiple locations and fixtures around the school and sent the samples to Technology Laboratory, Inc., and Colorado Analytical Laboratory for independent testing. While most of the water samples showed copper levels below the Environmental Protection Agency action level, the lab results did show copper above EPA action levels in several fixtures and hydration stations/water bottle-filling stations at WMHS.

What is considered an elevated level of copper?

The Environmental Protection Agency (EPA) "action level" for copper concentration in drinking water is 1.3 parts per million (ppm), meaning they must take mitigation actions if a water provider finds copper levels of 1.3 ppm or higher in more than 10% of customer taps sampled.

What copper levels were found at WMHS?

PSD took water samples from three bottle filling stations at WMHS on Dec. 20 and conducted additional testing on 47 bottle filling stations, taps, and sinks in WMHS on Dec. 22. Test results showed copper concentration results ranging from 0.1225 ppm to 5.29 ppm. Thirty-five of the 47 locations tested on Dec. 22 showed copper concentrations **below** the EPA action level of 1.3 ppm.

What is being done to bring copper levels down at WMHS?

PSD is taking the following steps, among others, as approved by the Larimer County Department of Health and Environment (LCDHE):

- Kept all hydration stations/drinking fountains and sinks closed for the time being
- Posted signs at the stations to remind people not to drink water from them
- Water coolers from Rocky Mountain Bottled Water have been placed throughout the building for students to refill water bottles
- Adjusted school meal menus to exclude items that require water for preparation until kitchen filters are installed
- Investigating options with filters for hydration stations/drinking fountains and kitchen faucets

Were any other school drinking water sources tested for copper? What were the results?

Five schools were tested in all, including WMHS, which is one of PSD's newest schools. Timnath Middle-High School and Bamford Elementary School, which opened in 2022 and 2021, respectively, were tested in case the elevated copper levels were new construction-related. Water samples from three bottle filling stations at TMHS showed copper levels averaging 0.37 ppm. Water samples from two filling stations and a sink at Bamford showed copper levels averaging 0.249 ppm.

In addition, Eyestone and Rice elementary schools' water was tested. The average result from Rice's bottle filling stations was 0.86 ppm, and the average result from Eyestone's bottle filling stations was 1.099 ppm.

In addition, the general contractor that built WMHS confirmed PSD's water test results for WMHS through its own testing. Town of Wellington staff also sampled the distribution line that supplies water to WMHS and had samples tested by Weld County Department of Health and Environment and Colorado Analytical, which did not show elevated levels of copper.

Can a person get sick from copper in drinking water?

Copper is an essential mineral for the body, and copper toxicity is rare, according to Larimer County Department of Health and Environment Medical Officer Dr. Paul Mayer. Eating, drinking, or breathing high levels of copper over time could potentially cause gastrointestinal symptoms such as stomachache, nausea, and diarrhea, along with headache, dizziness, and fatigue. Negative health effects related to potential exposure to high levels of copper can be diagnosed and treated by a healthcare provider.

What testing will be done in PSD schools going forward?

In accordance with Colorado House Bill 22-1358, testing of water in PSD elementary schools will start this month. These tests will look for both copper and lead levels. PSD will also test secondary schools.

Colorado Analytical Laboratory test results show that some samples taken by Poudre School District at Wellington Middle-High School are above the EPA action level. Should I be concerned for my child's health?

According to the county and state health departments, healthy children without a genetic disorder of copper metabolism or a diet unusually high in copper and weighing around 100 pounds, would have to drink 0.63 L of water per day for five days per week for four months straight at the maximum level found in one of the drinking fountains at WMHS of 5.29 ppm to reach the lowest observed adverse effect level, when minor reversible symptoms like stomachache could occur.

Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney damage. For symptoms associated with severe toxicity such as liver or kidney damage, a 100-pound healthy person without a genetic disorder of copper metabolism or a diet unusually high in copper would need to drink roughly 9.0 L of water per day for five days per week for four months straight at the maximum level found in one of the drinking fountains at WMHS of 5.29 ppm to reach the lowest observed adverse effect level.

Parking Reminders

This is a friendly reminder that Wellington Middle-High School (WMHS) requires all students and staff parking on campus to display a valid parking permit. This practice is standard across all six of Poudre School District's comprehensive high schools.

Currently WMHS provides parking to students and staff at no charge, while still emphasizing the importance of displaying a valid parking permit. For security purposes it is important for administrative and security staff to know who is parked on our campus whether student, staff, parent, or visitor. The best way for us to accomplish our goal is to have a comprehensive parking program that helps to identify vehicles and their responsible party.

Parking permits can be obtained by submitting an online parking permit application on the WMHS <u>website</u>. Students will be required to show proof of a **valid driver's license, vehicle registration, and insurance** specific to their vehicle(s) prior to obtaining their hang tag permit.

It is important to know that failure to obtain a parking permit and/or failure to follow parking rules may result in violations/warnings and the possibility of parking privileges on PSD property being temporarily or permanently suspended. Vehicles with multiple violations or more than two warnings for failure to obtain or display a valid parking permit may be "booted" using an immobilization device until appropriate permit registration is complete.



The Lorenzo de Zavala (LDZ) Youth Legislative Session is the most recognized program of the National Hispanic Institute (NHI). The intense, eight-day, model government session gives high-achieving, rising high school junior and senior students the opportunity to understand organizational culture, protocol, and procedures to become more effective community leaders, meet and collaborate with new friends, reflect on the issues of the day and practice leadership.

Poudre School District is proud to support the National Hispanic Institute's Lorenzo de Zavala (LDZ) Youth Legislative Leadership Program hosted by Colorado State University in June 2023. It is our mission to encourage families and students to participate in programs that advance their potential to contribute to their community.

ELIGIBLE STUDENTS:

- You must be a current 10th or 11th grade student in a Poudre School District high school
- You must have a 3.2 GPA or higher; if lower, a letter of recommendation will be required
- Your online LDZ application must be completed by January 12, 2023. To fill out your application visit https://www.nationalhispanicinstitute.org/ldz/
- ***Important**, when you register, choose Poudre Public Schools, and use **POUDRE** as the code. This will allow you to apply without paying the \$25 registration fee.
- You must participate in an interview with CSU staff to determine your eligibility for Team PSD/LDZ. A CSU staff
 person will text or email to set up an appointment time. Interviews will be held by Zoom after January 12, 2023.
- Students who participate in the Lorenzo De Zavala (LDZ) Youth Legislative Session and are admitted as freshmen to Colorado State University may be eligible to receive the Partnership Award. Funds for this award are awarded for up to five years or 10 semesters of enrollment at Colorado State University
